2020	A new Student Services Area was created to include 2 new counselling spaces.
2020	At our Sevenoaks campus, a third science lab opened.
2020	Our old Science block at Tonbridge was replaced by a state-of-the-art block including the latest physics labs.

2022	A new Heating and Cooling systems was installed at our Tonbridge in the Humanities building.
2023	Dedicated study space was created at our Sevenoaks campus for our Sixth Formers.
