

DEED OF VARIATION

The parties to this Deed are:

(1) The Secretary of State for Education ("the Secretary of State"),

- and -

(2) The Weald of Kent Grammar School Academy Trust a charitable company incorporated in England and Wales with registered number 7451660 ("the Academy").

together referred to as the "Parties"

INTRODUCTION

- A. The Parties entered into a funding agreement dated 28 January 2011 ("the Funding Agreement") relating to the establishment, maintenance and funding of an independent school known as The Weald of Kent Grammar School.
- B. The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

LEGAL AGREEMENT

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Funding Agreement, bear the meaning given to it in the Funding Agreement.
- 2. The Secretary of State and the Academy agree that with effect from the date of this Deed the Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
- 3. As varied by this Deed, the Funding Agreement shall remain in full force and effect.

Schedule 1

Amendments to the Funding Agreement

1. Clause 17 of the Funding Agreement shall be replaced with:

The planned capacity of the Academy, from 1 September 2017 is 2475 in the age range 11-18 years, including a sixth form of 700. The Academy will be a school whose requirements for:

- (a) the admission of pupils to the Academy are set out in Annex B to the Funding Agreement;
- (b) the admission to the Academy of and support for pupils with SEN and with disabilities (for pupils who do not have statements of SEN) are set out in Annex C to the Funding Agreement;
- (c) pupil exclusions are set out in Annex D to the Funding Agreement;
- (d) the procedure for the removal of the Academy's selective admission arrangements is set out in Annex E to the Funding Agreement.

2. Reference to "the Land" in clause 4 of the Funding Agreement shall be replaced by the following:

"the Land" means both the land (including for the avoidance of doubt all buildings, structures, landscaping and other erections) situated at and known as Weald of Kent Grammar School, Tudeley Lane, Tonbridge, Kent TN9 2JP and registered under title number K966335 and the annex at Seal Hollow Road, Sevenoaks, Kent under title number K971987.
